CONDITIONS OF ENTRY-THE FINE PRINT

1. All entries must be the RECENT and ORIGINAL work of the artist and not previously entered in the Jindabyne Lions Easter Art Show unless otherwise agreed with the organisers. The Entry Form (original or a copy) must be submitted with the entry.
2. Entry fee is \$10 per item for Adult Categories and \$5.00 Youth Categories.
3. Payment may be submitted with the exhibit or by direct transfer to Jindabyne Lions BSB 062655 Acct 10012726 Ref – Art Show “Artist’s Name”. Exhibits must be delivered to Jindabyne Memorial Hall, Kosciuszko Road Jindabyne on **SUNDAY 25 March 2018 from 10am to 4pm** unless other arrangements have been made with the organisers. Couriered or mailed entries may be sent to 104 Gippsland Street Jindabyne NSW 2627 prior to this date and must be accompanied by return postage or freight payment. PLEASE NOTE THAT LATE ENTRIES CANNOT BE ACCEPTED.
4. All entries must be for sale for a minimum of \$50 for Adult Categories and \$10 for Youth Categories. Maximum sale price is \$1500.
5. Entries not properly prepared for hanging or display may be rejected. Heavy items which are to be hung must have appropriate strength wire and fixings on the work or frame. Thin metal photo frame clips are not acceptable.
6. Maximum entry size is 800 wide x 1200 high unless otherwise arranged. Should space constraints apply, entries will be limited to five per entrant.
7. Each entry must be identified with a label or tag on the underside or back showing: Title of the work, Artist’s name, telephone or email contact, entry category, medium and sale price.
8. As outlined in the Indemnity agreement, the Lions Club of Jindabyne Inc. will not be held responsible for any loss or damage to exhibits although every care will be taken while exhibits are in our custody. Entries delivered by post or courier must be securely packaged.
9. A commission of 25% will be charged on all sales. Artists must complete the Statement by a Supplier or ABN information on the Entry Form otherwise 46.5% withholding tax will be retained from the price of any works sold.

OPENING NIGHT

The Opening Night, Announcement of Prize Winners, and Start of the Sale will be on **THURSDAY 29 March 2018 from 7pm to 10pm**. The cost is \$15.00 per Adult and \$5.00 per Child including beverages and supper. All are welcome.

ART SHOW AND SALE

The Art Show and Sale will be open from 10am to 5pm from **FRIDAY 30 March to Monday 2 April 2018, and from 10am to 4pm from Tuesday 3 April to Saturday 7 April 2018**.

COLLECTION OF EXHIBITS

All unsold exhibits must be collected from Jindabyne Memorial Hall on **SUNDAY 8 April 2018 between 1pm and 4pm** unless other arrangements have been made. Payment for sold works will be sent to the artist after completion of the event.

PRIZES and CATEGORIES

Adult prizes totalling up to \$2500 will be awarded. A “Best in Category” will be awarded for each category attracting five or more entries. A “Best in Show (Traditional)” and a “Best in Show (Contemporary)” prize will too be awarded. A Lyn Ritter Memorial encouragement prize may be granted to an outstanding emerging artist who has not previously won an award.

Youth prizes totalling up to \$400 will be awarded. A “Best in Category” will be awarded for each category of Painting, Drawing, Photo, Sculpture & Craft for Secondary School and for Primary School youth age groups.

In addition to the above, prizes totalling up to \$250 will be awarded by National Parks and Wildlife Service for artwork that reflects the “Spirit of the Snowies” across all categories.

- The Principal shall not be liable in respect of any loss or damage whatsoever, whether arising in contract, tort or otherwise, sustained by the Artist or any other person which may be sustained in connection with any act or omission relating to the performance or non performance by the Principal or any of its officers, servants or agents. Such loss or damage shall include, but without limiting the generality of the foregoing, loss or damage caused by the negligence of the Principal or any of its officers, employees or agents or others, whether consequential or otherwise and whether or not such loss or damage is reasonably foreseeable.
